REQUEST FOR EXPRESSIONS OF INTEREST

1. Tanga City is located in the Northern East of Tanzania Mainland along the Indian Ocean. It lies between longitude 38°53' and 39° 10' east of Greenwich and between latitude 5° and 5°16' south of Equator. It serves as the administrative and commercial centre for Tanga Region and the second largest port in the Country. Chongoleani area has been the key area for the ongoing East African Crude Oil Pipeline (EACOP) project, where an export facilities and oil related facilities to be constructed at that area. The Tanga City Council in corporation with other development partners intends to procure consultancy services for preparing the detailed planning scheme of **PROPOSED CHONGOLEANI OIL CITY** covering a **total 85.58 square kilometre**.
2. **The primary objective** of the assignment is to **PREPARING THE DETAILED PLANNING SCHEME OF PROPOSED CHONGOLEANI OIL CITY** covering a total **85.58square kilometres**. This priority project should be prepared such that it could be presented to donors for possible support.
3. The Tanga City Council now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are: (i) general experience in the specialized Cities planning; (ii) experience in undertaking feasibility studies and design of Cities (iii) successful execution of at least two similar

projects (by size and complexity) in the developing countries. Information to be provided should include name of assignment, name and full contact address of the client, specific input, experts and tasks performed by the consultant under the assignment, assignment value, period (dates) of execution of assignment, etc.

Firms may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications.

4. This is **not** a request for proposals (**RFP**). After a review of the expressions of interest, a shortlist will be prepared and the short-listed consultants will be invited to submit their proposals through a letter of invitation including specific terms of reference. A consulting firm will be selected in accordance with the Quality and Cost Based Selection method (QCBS) set out in the Tanzania Public Procurement Act of 2011 and its amendments of 2016.
